<u>Please note that</u> if, after the initial two-year subscription, you want to renew your subscription, such renewal will not be free (and will be subject to the then-current prices). Suppose you prefer not to renew the subscription. In that case, you will be granted a limited, non-exclusive, revocable license to continue using a starter set (of ten games) on the Tovertafel as long as the Tovertafel is in use (provided you comply with the license and do not infringe on Tover's IP rights).

**Please note that** the specifics of the prize shall be solely determined by Tover and prize substitution shall only be permitted at Tover's discretion. In no event, the prize can be substituted in cash. The prize is non-transferable and any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the Winner.

#### Eligibility

Participants must meet all criteria to be eligible for participation in the contest. You have entered into the contest once you have successfully completed all two steps in the section "How to enter the contest" below (walking through all cumulative steps will qualify as "an **Entry**"). Your Entry shall be void if your (eligibility for) participation in the contest is prohibited by applicable federal, state and/or local laws.

• Entries must come from (i) professionals working in a Not-For-Profit senior care community located in the Contiguous United States (Staff member, Director, Manager etc.) or (ii) family members of residents of a



Not-For-Profit senior care community located in the Contiguous United States. In the event of doubt, Tover may ask you to provide evidence thereof (which you shall provide at first request).

- The entering participant must be over 18 years of age (as of the date of Entry).
- Participants must be legal residents of the US.
- Employees of Tover (and their immediate family members), affiliates and suppliers of Tover are not eligible for participation in the contest. The same applies to advertising and promotion agencies.
- Since we make use of Social Media Platforms to promote our contest, you must also comply with the following policies/community guidelines: <u>Youtube</u>, <u>Instagram</u>, <u>Facebook</u> & <u>Linkedin</u>. If it becomes apparent that you have violated any of these policies/guidelines (or if Tover has a reasonable suspicion that you have done so), then you may at Tover's sole discretion be disgualified from the contest.
- **The number of entries is limited to one entry per senior care community and per participant** (no double entries by the same organization or the same person). In the event of multiple entries, only the first will count as a valid Entry.

#### • How to enter the contest

To enter the contest you should complete the following (cumulative) steps before October 5th 11:59 PM (PDT):

- **Step 1**: Share your most creative and purposeful activity used with residents living with dementia included in a comment under a pinned post on our Tover US Facebook page (<u>link</u>); and
- **Step 2:** Complete the registration form on our website (<u>link</u>). The information provided should be complete, up-to-date, and correct.

**Please note that** your entry must be in "good taste" and in keeping with the Sponsor's brand image and must not be explicit, offensive, obscene, or profane, and must not be derogatory toward any ethnicity, race, gender, sexual orientation, religion, profession, or age group, or promote any activities that may be unsafe or dangerous, as determined by the Sponsor. A breach of the aforementioned rule may - at the sole and absolute discretion of Tover - result in disqualification.



**Please also note that** entries that are not complete or do not adhere to the contest rules or specifications may be disqualified at the sole discretion of Tover. Any and all (suspected) fraudulent methods of entry or circumvention of the rules may result in Tover invalidating your entry (at Tover's sole discretion).

### • Intellectual property

Your submission must be original work and may not violate anyone's proprietary or intellectual property rights. If this condition is not met, you will be disqualified from the contest. **Please note that** any use of Artificial Intelligence to (help) generate your submission is at the risk of the Participant. BY PARTICIPATING IN THE CONTEST YOU ALSO AGREE THAT YOU SHALL DEFEND OR SETTLE AGAINST ANY AND ALL CLAIMS THAT MAY ARISE FROM OR ARE OTHERWISE RELATED TO YOUR VIOLATION OF ANYONE'S PROPERTY OR INTELLECTUAL PROPERTY RIGHTS AT YOUR SOLE EXPENSE AND THAT YOU SHALL INDEMNIFY, DEFEND AND HOLD HARMLESS TOVER FROM ANY AND ALL CLAIMS THAT ARE RELATED TO YOUR SUBMISSION.

### • Rights granted by the Participant

### • Third-party rights

To the extent that your submission contains footage (whether audio, photo, and/or video) and other people than yourself can be heard and/or seen in such footage, you must ensure that you obtain their (or their legal representative's) explicit consent for recording and subsequently submitting this footage for participation in the contest (and that if such consent is provided, you adequately save proof thereof). #### • Timing

- The contest Entries may be submitted from September 20th, 2023 00:00 AM (PDT) onwards.
- The contest closes on October 5, 2023 at 11.59 pm (PDT).
- Entries submitted before September 20, 2023, or after October 5, 2023, will be deemed invalid entries (and consequently will not be taken into consideration when the winner is determined).

#### • Deciding on the winner

- The winner will be the senior care community listed on the registration form of the participant who has, according to the public, entered the most creative and purposeful activity which will be the participant whose comment under the Facebook ToverUS pinned post on September 20th, 2023 has generated the most likes and reactions on October 5, 2023 at 11.59 (PDT)(hereafter referred to as "the **Winner**"). In the event of a tie, the senior care community listed on the registration form of the participant who has entered the contest first (measured by the date and time on which all three steps for entering into the contest were completed) shall be the Winner.
- Tover has the right to refuse, withdraw, or disqualify entries at her sole discretion, for example: if it appears that a senior care community listed in a registration form is actually a For-Profit senior care community.
- By entering into the contest, you agree and acknowledge that the decision of Tover (on who has won the contest) is final and binding.
- Before the Winner is announced, Tover will contact them through email (through the email address provided in the registration form) shortly after the deadline. If the participant does not respond and confirm the care



community designated on their registration form as Winner within 5 business days, then Tover reserves the right to rescind the prize and award it to another care community instead (i.e., the runner-up).

• Tover is not liable for non-receipt of entries due to any circumstance and/or the participant's failure to receive notification of winning if for example he/she provided a wrong email address or if their email security settings caused the price notification to end up in a spam or junk folder or for any other reason.

### What happens next if your designated senior care community has won?

- The receipt of the prize by the Winner is conditional upon:
  - The Winner signing a winner's affidavit that shall include:
    - A tax acknowledgment (including an obligation to complete or to help complete a 1099 MISC form);
    - The Winner's permission to use the Winner's name (and where relevant logo) for purposes of news and advertising related to winning the prize without further compensation, unless prohibited by law;
    - A requirement to use the Tovertafel in the senior care community and an obligation to not use the prize for commercial gain (for example by reselling or rent the prize or parts thereof);
